## November 2024: GLOBAL MARKET INDEX PERFORMANCE

Global equity and bond returns were mostly positive in November. The S&P 500 returned 5.9% and the MSCI ACWI increased 3.9%, while developed non-U.S. equities (MSCI EAFE) fell -0.6%. In the U.S., growth stocks outperformed value. The Bloomberg Aggregate Bond Index returned 1.1% and U.S. High Yield returned 1.2%. U.S. CPI slowed its advance, as the year-over-year inflation rate decreased from 2.4% through October to 2.2% as of November 2024.

Both stock and fixed income markets delivered positive performance in November with US election results being the primary driver of market performance. After Donald Trump's presidential victory, prospects of a strengthening US dollar, more nationalist trade policy, fiscal policy extensions, and further tax cuts boosted results. Although the Fed cut its target interest rate by 0.25%, bond markets only marginally benefited from looming concerns over future inflation.
